3. Such contact, as described in No. 1 above, may result in injury to my Child; and
4. A number of minor children will be in attendance at any particular Activity and at each Activity there will be a limited number of Bluegrass coaches and supervisory personnel; as a result, no participant can receive constant and uninterrupted individual attention and supervision for the duration of any Activity.

In addition to the above I also do hereby acknowledge and represent the following:

1. My Child is physically fit and mentally capable of participating in field hockey related Activities ("FH Activities") and any and component of any FH Activity or Activities in which my Child is involved; and
2. I have sought the opinion of my Child's physician and my Child's physician concurs that my Child is fully capable of safely engaging in field hockey and any FH Activity in which my Child is involved; and

Spring Field Hockey

Our Spring Session provides opportunity for athletes of all skill levels. Basic to advanced skills are taught along with strategic game knowledge for those choosing to participate in play days and tournaments. Our coaches have extensive coaching and playing experience and are among the top coaches in the region. We pride ourselves on a very consistent coaching staff as our former athletes continue to come back and coach. We offer something for everyone from those looking for a recreational session to competitive national travel and college recruiting guidance.

This is an 8-week program that starts the week of March 18 and ends May 19, 2019. There will be no practices over Spring Break and no practices on Oaks or Derby.

Practice

Practices are located at different locations – We practice on surfaces that are used for various spring tournaments. We do this so that we are on the surfaces similar to national and regional tournaments are played.

U19's will practice twice a week for 2 hours each – one practice on grass, and one on turf.

U16's will practice twice a week for 2 hours each – one practice on grass, and one on turf.

U14's will practice twice 1.5 hours during the week and 2 hours on the weekend – one practice on grass and one on turf.

U12's will practice twice a week for 1.5 hours each – practice at Seneca Park.

*U19, U16, and U14 will practice at duPont Manual's Rachel Baker Memorial Field (corner of 2nd and Hill) and a turf location to be announced once your registration is processed.

*We may schedule additional practices for travel teams or make up sessions (due to weather cancellations).

Age Requirement

U12 and under = 11 or younger on January 1, 2019

U14 = 12 or 13 on January 1, 2019

U16 = 14 or 15 on January 1, 2019

U19 = 16, 17, or 18 on January 1, 2019

Equipment

Once we receive your completed registration, signed waiver, and payment we will email you with your practice schedule. **These spots will be filled on a first come basis.** You will need a stick, shin guards, mouth guard, and a water bottle. These items are mandatory.

Registration DEADLINE is February 28, 2019

Space is limited to the first 60 per age group. No athlete will be permitted to attend practice without complete registration paperwork and payment. No exceptions. There is a \$50 late fee for any registration received via email or postmarked after February 28th. Refunds are only issued on an individual basis.
